Conditional, illegible, ambiguous tender(s) and tender(s) without CDR/FDR or received after the stipulated date and time shall be out rightly rejected. The tender(s) will be opened on the same day or any other subsequent day convenient to the undersigned in presence of such tenderers who may like to be present on spot.

Terms and Conditions to Notice Inviting Tender No. CO/PUR/135/6878 dated 22-09-2009

- 1- The firms registered with Shri Mata Vaishno Devi Shrine Board, Katra for supply of the tendered items will be given preference.
- 2- The rates quoted shall be net F.O.R. Engineering Stores, SMVDSB, Banganga (Katra) inclusive of all taxes / charges.
- 3- The quantities of Sal Wood Cut to Size shall be ± 1200 Cft. which is indicative in nature and can be increased / decreased according to our requirements from time to time during the rate approval period.
- 4- The Shrine Board reserves the right to approve the rates of more than one bidder declaring them as "Successful Tenderers" and split the demand during the period under reference.
- 5- The rate approval order finalized w.e.f. the date of approval on the basis of these tenders shall remain valid for a period of one year. The supplier will have to supply the material against the supply orders issued by this office from time to time during the rate approval period.
- 6- In case the successful tenderer (s) fails to make supply in full the balance material shall be arranged at his risk and cost.
- 7- In case the supplier fails to supply the material within the stipulated period he/she shall be liable to penalty for the delays: - i) upto 15 days @ 1%, ii) from 16 days upto 22 days 1.5%,iii) From 23 days upto 30 days @2%. Iv) Beyond 30 days, the supply order will be deemed to have been cancelled. In that event the CDR of the supplier will be forfeited in favour of Shri Mata Vaishno Devi, Shrine Board, Katra and the rate approval order shall be treated as cancelled & the material shall be procured from the open market at the risk and cost of the defaulter supplier & the defaulter supplier will be debarred from any further dealing with the Shrine Board.
- 8- In case of incomplete supply, an amount equal to 2% of the total value of non-supplied material shall be deducted from the due payment of the supplier.
- 9- These terms and conditions will form an integral part of the contract with the successful tenderers.
- 10- All the disputes are subject to jurisdiction to the Court of Law at Reasi / Katra.
- 11- The Addl. Chief Executive Officer, SMVDSB, reserves the right to terminate the rate approval order during its validity without assigning any reason there to.
- 12- In case of any dispute arising out of the contract, the Chief Executive Officer, SMVDSB, Katra shall be the Arbitrator and his decision shall be final and binding upon both the supplier as well as the Shrine Board.
