NOTICE

For Running Bhandaras during Shri Amarnathji Yatra 2007.

1. Shri Amarnath Ji Shrine Board (SASB) invites applications from NGOs who wish to run Bhandaras for the Yatra 2007.
2. Applicants must specify the dates for which they intend to run Bhandara (From _____ to _____).
3. No change in dates will be accepted after the issue of permission.
4. Dates for Yatra 2007 are from 30 June 2007 to 28 August 2007 (both days inclusive). However Ist batch of Bhandaras would be required to be functional on 21st June 2007.
5. Structure for non refundable / refundable deposits will be as under:-
 - a. Non-refundable (for Partially Meeting Obligatory Expenses incurred by SASB on each Bhandara).
 - i. Running Bhandara for complete duration of two months from 30 June to 28 Aug. 2007 – Rs. 15,000/-
 - ii. Running Bhandara for 15 days to One Month - Rs. 10,000/-
 - b. Refundable security deposit – Rs. 10,000/- for all Bhandaras irrespective of duration.
6. Envelope carrying application will be marked as “For Bhandara Only”. Application will be accompanied by a Demand Draft for Rs. 25,000/- (Twenty Five Thousand Only) or Rs. 20,000/- (Twenty thousand only) as applicable, payable to the Chief Executive Officer, Shri Amarnathji Shrine Board at Jammu towards the prescribed refundable / non- refundable deposit.
7. Complete amount will be refunded to those whose applications are rejected.
8. Permission granted to those first phase bhandaras will automatically stand cancelled which fail to be functional on 21st June 2007 at the locations allocated to them by the SASB for the Yatra 2007. These Bhandaras will have to voluntarily vacate the place on 21st June 2007 itself, failing which they will be forcibly evicted on the same day by 2 PM.
9. Applications will be considered strictly on the following merits:-
 - a) NGOs who have run the Bhandara during Yatra 2006 with desired dedication towards yatries etc. and against whom no adverse report has been received from the Camp Director / SASB Staff / Any Govt Agency.
 - b) Ist come Ist served basis thereafter, out of those who qualify Clause 8 (a) above.
 - c) Accompanied by the requisite DD of Rs 25,000/- or Rs. 20000/- as applicable.
 - d) Acceptance of the terms and conditions , framed by the SASB keeping past experience and welfare of yatries in view, in totality without attaching any conditions from their side . Copy of Terms and Conditions is attached.

10. It may please be noted that no compromise on security aspects can be accepted. Therefore only security cleared Sewadars should be sponsored. Applications for them on prescribed forms shall have to be submitted to Dy. CEO duly completed in all respects by 31 May 2007 to enable issue the identity cards for Bhandaras approved for 2007 yatra.
11. Merely sending / submitting application for Bhandara does not entitle getting any permission.
12. SASB will have the right to accept or reject any application without assigning any reasons.
13. Courts in the State of J&K only have the jurisdiction in all disputes.
