



stabilization of vulnerable stretches has been done by cladding and construction of retaining walls to protect yatris against vagaries of nature like landslides and shooting stones. An 8 feet high welded mesh fence has been erected all along the tracks as an added safety measure. With operationalisation of state-of-the-art Multipurpose Audio System along the entire stretch of track from Banganga to Bhawan, the ambience and spiritual bliss has further been enhanced with devotional music, spiritual songs, "Chants", "Mantras", "Stotras" and Bhaints. This facility is also being commissioned on the Tarakote Marg between Katra and Adhkuwari very soon.

2.4 The rudimentary drinking water facility that existed prior to the establishment of the Shrine Board has been replaced with a large number of potable drinking water points and water coolers to ensure safe and continuous drinking water supply all along the track. Besides, water ATMs have also been installed at several points to provide free of cost ultra filtered water to yatris.

2.5 The entire track from Katra to Bhawan has been adequately lit with LED lights presenting a beauteous view of the Bhawan and the entire Shrine area during nights.

2.6 Adequate arrangement of healthcare has also been made for the piligrims with availability of qualified medical professionals and infrastructure in the medical units operating on different locations on the track. Provision of ambulances has also been made on the track to shift patients for specialized treatment at CHC Katra and Shri Mata Vaishno Devi Narayana Superspeciality Hospital, Kakryal. Adequate arrangements are in place to shift the serious cases to SMVDNSH, Kakryal on Board's expenses.

2.7 Sanitation has been accorded very high focus by the Shrine Board and adequate sanitation staff has been deployed 24x7 to keep the track, Page 2 of 76 stabilization of vulnerable stretches has been done by cladding and construction of retaining walls to protect yatris against vagaries of nature like landslides and shooting stones. An 8 feet high welded mesh fence has been erected all along the tracks as an added safety measure. With operationalisation of state-of-the-art Multipurpose Audio System along the entire stretch of track from Banganga to Bhawan, the ambience and spiritual bliss has further been enhanced with devotional music, spiritual songs, "Chants", "Mantras", "Stotras" and Bhaints. This facility is also being commissioned on the Tarakote Marg between Katra and Adhkuwari very

- establishment of the Shrine Board has been replaced with a large number of potable drinking water points and water coolers to ensure safe and continuous drinking water supply all along the track. Besides, water ATMs have also been installed at several points to provide free of cost ultra
- The entire track from Katra to Bhawan has been adequately lit with LED lights presenting a beauteous view of the Bhawan and the entire Shrine
- Adequate arrangement of healthcare has also been made for the pilgrims with availability of qualified medical professionals and infrastructure in the medical units operating on different locations on the track. Provision of ambulances has also been made on the track to shift patients for specialized treatment at CHC Katra and Shri Mata Vaishno Devi Narayana Superspeciality Hospital, Kakryal. Adequate arrangements are in place to
- Sanitation has been accorded very high focus by the Shrine Board and adequate sanitation staff has been deployed 24x7 to keep the track,



- establishments and the entire Shrine area clean. For the purpose, latest eco-friendly green technologies have been adopted to achieve the desired results. These initiatives of the Board have been duly recognized at the national level with Shri Mata Vaishno Devi, Katra, having been selected by the Central Government under the Swachh Iconic Places Project. This has started giving boost to sanitation, cleanliness and civic amenities in Katra and the Shrine area through a range of infrastructural and technological interventions. Shri Mata Vaishno Devi Shrine has won recognition on national level in 2017 and 2018 for being one of the 'Best Swachh Iconic' places.

 2.8 The tin-shed housed toilets that existed prior to 1986 have been replaced with au courant Toilet Blocks with waterless urinals on track, residential accommodations and establishments of the Board. Switching over to this technology has an added advantage of saving a large quantity of water which was otherwise required for flushing of traditional toilets. A chain of Sewage Treatment Plants has been put in place which has given further impetus to the efforts of the Shrine Board towards protection of environment and ecology. The massive plantation along the track and greening of the entire Trikuta Hills is also a significant part of this initiative.

 2.9 Further, despite geographically challenging terrain, a number of other major piligrim-centric infrastructure development projects have been completed, many are under execution and several others are in the pipeline to meet the futuristic requirements of the piligrimage. These include formulation of a Master Plan for Bhawan and the Extended Shrine Area, which is being implemented in a phased manner. This will in a big way further add to the existing facilities for the pilgrimage have resulted in a phenomenal upgradation of facilities for the pilgrimage have resulted in a phenomenal

increase in the number of pilgrims visiting the Holy Shrine. The number of yatris which was 13.96 lakh in 1986 stood at 85,86,541 in 2018.

2.11 As provided in the Act, the Governor of the State of J&K is the ex-officio Chairman of the Shrine Board who can nominate (in the manner as prescribed in the 'Act') upto nine eminent persons to the Board as its Members.

3. Mandate of the Shrine Board

Section 18 of the Shri Mata Vaishno Devi Shrine Act of 1988 assigns the following duties to the Board:

- 1. To arrange for the proper performance of worship at the Shrine.
- To provide facilities for the proper performance of worship by the pilgrims.
- 3. To make arrangements for the safe custody of the funds, valuable security and jewellery and for the preservation of the Shrine Fund.

- 4. To undertake for the benefit of worshippers and pilgrims:
 - a) The construction of buildings for their accommodation;
 - b) The construction of sanitary work; and
 - c) The improvement of means of communication.
- 5. To undertake the developmental activities concerning the area of the Shrine and its surroundings.
- 6. To make suitable arrangements for the imparting of religious instructions and general education.
- 7. To make provision of medical relief for worshippers and pilgrims.
- 8. To make provision for the payments of suitable emoluments to the salaried staff.
- 9. To do all such things as may be incidental and conducive to the efficient management, maintenance and administration of the Shrine and the Shrine Fund and the convenience of the pilgrims.


7. Audit Report



On arrival at the Panchhi Helipad from Jammu, the President was received by Sh. Umang Narula, the then CEO of the Shrine Board.









The then Governor gave a brief description of the two projects. Tarakote Marg is a 7.5 km long ramp style track which connects Banganga to Adhkuwari and has been completed at a cost of over Rs. 80 crore. It has been constructed for pilgrims who wish to walk to the Shrine. The opening of this Marg has very significantly decongested the existing Banganga-Adhkuwari track on which mules and ponies also ply. Tarakote Marg provides well designed facilities for the comfort and convenience of the pilgrims. The Shrine Board has also constructed a 1.5 km Link Road to connect the existing Banganga - Adhkuwari track to the new Tarakote Marg.

As regards the second project, operation of the Material Ropeway, it has enabled transportation of construction and varied other materials from Siar Dabri to the Shrine. The Passenger Ropeway System has been fully equipped with all safety norms as per relevant standards and codes. It has two fully enclosed spacious Cabins with a carrying capacity of 40-45

14. Governor lays foundation of new Durga Bhawan to provide free accommodation for 4000 pilgrims

To add additional facilities for meeting the accommodation needs of the pilgrims who visit the Holy Cave Shrine of Shri Mata Vaishno Devi Ji, Governor Satya Pal Malik, Chairman of the Shri Mata Vaishno Devi Shrine Board, On 15 March 2018 laid foundation stone and launched the work for reconstruction of Durga Bhawan in the Bhawan area.

The Governor electronically laid the foundation and launched the work on this 5-storey building on the sidelines of the 64th meeting of the Shri Mata Vaishno Devi Shrine Board held under his chairmanship at the Raj Bhavan, Jammu.

This earthquake resistant building, with a covered area of 60,000 sft, is estimated to cost Rs. 50 crore and will provide free accommodation facilities to around 4000 pilgrims. It will have provision of 4 elevators for vertical circulation. The construction of Durga Bhawan is one of the four works of Master Plan Phase-I for 2021. It is pertinent to mention that the Master Plan seeks to achieve target of ensuring maximum free of cost accommodation for yatris by 2031.

15. Shrine Board launches hi-tech pre-paid system for hiring Ponies, Pithoos, Palkis by pilgrims

A hi-tech computerised pre-paid system, integrated with CCTV Cameras and Video Conferencing facilities, for hiring Ponies, Pithoos and Palkis, was launched from Katra on 26 February 2019 for the facilitation of pilgrims to the Holy Cave Shrine of Shri Mata Vaishno Devi Ji. This facility was made available to the pilgrims round the clock.

This system was formally inaugurated by Sh. B. S. Tuti, the then Deputy Inspector General of Police, Udhampur-Reasi; in the presence of Sh. Simrandeep Singh, Chief Executive Officer, Shri Mata Vaishno Devi Shrine Board; Ms. Indu Kanwal Chib, Deputy Commissioner, Reasi; and Ms. Nisha Nathyal, the then SSP, Reasi at a function held at the Spiritual Growth Centre at Katra.

The system has integrated nine Pre-paid Counters from Katra to Bhairon, located at Katra, Banganga, Charan-Paduka, Adhkuwari-I, Adhkuwari-II, Sanjichhat, Parvati Bhawan at Bhawan, Pony Stand Bhawan and Bhairon, from where the pilgrims get Pony, Pithoo, Palki services at pre-determined rates. The Counters also serve as Grievance Registration Centres for yatris, which is conveyed to the Shrine Board Administration at Katra in escalation format. Each yatri is also given a helmet, elbow and

knee pads to provide preventive cover against any accidental injury. The Counters also provide video conferencing facilities to the Shrine Board Office in order to monitor the activities and interact with employees at different yatra stations.

Under this system, a stand-alone network has been set up by G-Max Pvt. Services Ltd., a Jammu based company, which got this contract from SMVDSB under Build, Own, Operate and Transfer (BOOT) framework for five years.

The CEO of the Shrine Board said that the project is an outcome of NGT and Supreme Court orders on the issue of regulating mules, capping its count, management of mule dung and overcharging, etc.



18. Social Support Initiatives

Shrine Board in its endeavour to promote the interest of families living in the villages located in the close vicinity of the Shrine area has been carrying out various social and economic development activities for the past several years, which includes scholarships for meritorious students, financial assistance to girls for marriage, support to Self Help Group beneficiaries from Katra and nearby areas, medical insurance, and free health camps.

18.1 Promoting welfare of erstwhile Baridar families

As part of its various continuing programmes to promote the interests of the erstwhile Baridar families, Shri Mata Vaishno Devi Shrine Board released more than one crore rupees as scholarships to 1360 students belonging to the erstwhile Baridar families for the 2018-19 academic session. With this, the total amount paid by the Board as scholarships to students belonging to the erstwhile Baridar families from 2002-03 to 2018-19 crossed Rs. 5.29 crore, thereby benefiting 11305 students from this scheme of the Shrine Board.

Under the scholarship scheme of the Board, priority is given to promote the education of girls by providing them scholarships at a higher scale. The students studying in class 1st to the post-graduation level are provided scholarships ranging from Rs. 3,000/- to Rs. 18,000/- per annum. In the case of girls, the scholarship amount ranges from Rs. 4,200/- to Rs. 18,000/- per annum, depending upon the class in which the student is enrolled.

Based on their class-wise internal merit, scholarships are given to the top 10 meritorious students studying in I-XII class in government schools. As a special concession, the Shrine Board pays scholarships to Undergraduate and Post-Graduate Degree course students of erstwhile Baridar families studying anywhere in the

expenditure of around Rs. 77 lakh per annum on this account. The amount in respect of each beneficiary will mature after 21 years from the date of opening of the account, after which each girl will get a lump sum amount of approximately Rs. 5.62 lakh that can be utilised for the educational and marriage purposes. However, a partial withdrawal upto 50% of the balance is also allowed after girl attains 18 years of age.

The beneficiaries have been identified from families having an annual income ceiling of Rs. 75,000/- and residing in the Bhomag area of Reasi district of which seven villages do not have road connectivity while three other villages are accessible only through fair weather roads. The initiative is targeted to ameliorate the lot of economically poor households residing in such remote areas.

18.2 **Shrine Board's Medical Support Policy**

During the Financial Year 2018-19, Shri Mata Vaishno Devi Shrine Board spent an amount of Rs. 909.58 lakh under its Medical Support Policy for providing Medical Support to various categories of patients. These categories include pilgrims, Shrine Board's employees and their dependents, students of the College of Nursing, Gurukul, villagers (of Kakryal, Sira, Kotla and Sool villages) and the Land Owners (whose land was acquired for the setting up of SMVDU and SMVDNSH) and to poor and needy patients in general (under Arogaya Yoina, a component of the Medical Support Policy of the Shrine Board). Besides, the Board approved a Medical Support Policy for the treatment of victims of public trauma under its social support initiative at the Superspeciality Hospital. The beneficiaries in this policy include public trauma victims of road accidents, landslides or shooting stone incidents and such calamities from the surrounding areas of the Shrine referred to the hospital by the concerned Deputy Commissioners to provide emergency medical aid. Medical assistance is provided in all



such cases by the Shrine Board till the stabilisation of the patient upto a ceiling of Rs. 2 lakh as a goodwill gesture for such critical cases.

The Board also approved enhancement of Group Accidental Insurance cover for the pilgrims. The accidental cover extended to each pilgrim free of cost was enhanced from Rs. 3 lakh to Rs. 5 from lakh for the pilgrims aged 5 years and above and Rs. 3 lakh for the pilgrims below 5 years of age up from the existing Rs. 1 lakh. The Board also approved additional life insurance cover of Rs. 5 lakh to the pilgrims who avail the service of the Passenger Ropeway between Bhawan and Bhairon Ghati. This cover is in addition to the accidental cover available to each yatri once he / she collects the yatra slip and commences the journey.

The Board approved installation of a hi-tech Multipurpose Audio System on Tarakote Marg from Katra to Adhkuwari to play devotional music and spiritual songs comprising "Chants", "Mantras", "Stotras", Bhaints, besides ensuring reliable and real time dissemination of informative advisories and announcements.

The Board also approved a scheme for institutionalising fellowships for the top 5 meritorious students of Shastri classes of the Shrif Mata Vaishno Devi Gurukul for pursuing Acharya or equivalent Post-Graduation Course in Sanskrit, Jyotish, Darshan and Ved streams in the leading institutions of the country. The merit fellowships will be provided to the students for a period of 2 years based on their academic performance during three years of the Shastri Course. The amount of fellowship to be provided by the Shrine Board will be Rs. 48,000/- per annum to the meritorious scholar.

The 63nd Board meeting was attended by Dr. S. S. Bloeria, Dr. Ashok Bhan, Sh. H. L. Maini, Sh. Justice (Retd) Permod Kohli, Maj. Gen. (Retd) Shiv Kumar Sharma and Sh. B. B. then Chief Executive Officer of the Shrine Board, Sh. Simrandeep Singh, the then designate Chief Executive Officer of the Shrine Board, Dr. M. K. Kumar and Sh. Anshul Garg, the then Additional Chief Executive Officers.

At the 64th meeting the Board approved installation of CCTV Surveillance System on the entire track from Darshani Deodi to Bhawan, which besides helping in monitoring the movement of the pilgrims and strengthening overall security measures, will also be of immense support in case of any emergent situations to provide real time assistance to the Shrine Board and local administration: installation of stand-alone STPs for the Toilet Blocks on the yatra route at estimated cost of Rs. 6.65 crore in an а phased manner.

Conservation of environment and ecology has been very high on agenda of the Shrine Board and in furtherance of this objective various measures have been taken from time to time and latest technologies adopted for creation and upgradation of sanitation infrastructure, collection and segregation of waste at source and bringing it to the identified sites for




In consonance with this, the Board has established a 4-ton per day capacity biogas plant at Banganga for scientific disposal of mule dung generated on the track enroute Bhawan. The biogas produced at this plant is supplied to the Gulshan Langar at Banganga. Besides, a composting project was also set up at solid waste management site at Tarakote on trial basis where mule dung was processed and converted into manure through pit composting technology. Upon successful results and to carry forward this initiative at a greater pace and on much larger scale, a full-fledged

project viz Equid Dung Management Centre has been established by the Shrine Board at Natali near Katra where scientific treatment of mule dung is being done both through aerobic and anaerobic methods.

Since the manure generated through pit and bed methodology has very good capacity of holding moisture for longer duration, it is being used for various greening works in the Shrine area and besides supplying to the local farmers for boosting organic farming. The mule dung generated on the track is collected, segregated at source and brought to the mule dung composting site at Natali on daily basis for its treatment. For regular composting of mule dung, many new initiatives have been taken at Natali project which include erection of sheds in bed composting area for saving the compost beds from weather vagaries, fencing of the entire composting project area by using scrap material and planting of 6500 trees of forest species. The compost generated is also being used for growing seedlings and plants. Local seeds which are suitable for this region are also being propagated. An eco-friendly kitchen garden has also been established at Natali where different vegetables are being grown.

While making continuing endeavours for enlarging infrastructural and other facilities for the facilitation of the visiting pilgrims, the Shrine Board has been taking initiatives for transforming socio-economic development profile of Katra, the base town for the pilgrimage, its surrounding areas and the society at large. The thrust areas under this initiative, interalia, include the sectors of education, health care and sports. In furtherance of this objective, the Shrine Board has established Shri Mata Vaishno Devi University, Shri Mata Vaishno Devi College of Nursing, Shri Mata Vaishno Devi Gurukul, Shri Mata Vaishno Devi Narayana Superspeciality Hospital and Shrine Board's Sports Complex. These institutions are serving the society with distinction and have made a mark in their respective spheres.

22.1 Shri Mata Vaishno Devi University

Shri Mata Vaishno Devi University

Shri Mata Vaishno Devi University, established by the Shrine Board in 2004, is an autonomous, highly technical and fully residential university. It has witnessed a remarkable growth over the past 15 years. The varsity spread on a sprawling and picturesque campus in the backdrop of Trikuta Hills at Kakryal, near Katra, has come up in a big way both in the spheres of teaching and research. It has been equipped with hi-tech labs, hostels and other buildings to provide the best possible facilities of teaching and research to the students who seek admission in this university from across the country. The academic system, syllabi and evaluation procedure has been adopted from the Indian Institute of Technology which promotes vigorous learning and transparent evaluation mechanism. university are guiding the students towards higher learning and research with focus on building highly qualified manpower with abundance of integrity and humaneness. 
22.2 Shri Mata Vaishno Devi Gurukul

The Shrine Board has also established Shri Mata Vaishno Devi Gurukul at Charan Paduka near Katra in 2010 to provide quality modern education at this Gurukul along with Vedic and Sanskrit education. This initiative has been taken in furtherance of the duty of the Board to make arrangements for imparting of religious instructions and general education. The Gurukul has also been upgraded to provide education upto Shastri level from

the 2017-18 academic session for which Gurukul Phase-II has been constructed.

Presently, 162 students are studying in classes 6th to Shastri Part-II in the fully residential Gurukul, which is affiliated with the Sampurnanand Sanskrit Vishwavidyalaya, Varanasi, a leading Sanskrit University in the country. All the students are provided education, boarding, lodging, uniforms, books and other required facilities at the cost of the Board. Given the excellent infrastructural and other allied facilities provided by the Shrine Board to impart top quality education to the Gurukul students, they are bringing laurels in both academics and co-curricular activities year after year by their excellent performance.


Besides, the Gurukul also organizes refresher courses to sharpen skills of Pandits/Pujaris from the region and those serving in the Shrine Board.

22.3 Shri Mata Vaishno Devi College of Nursing

Continuing with its another initiative in the field of education, the Shrine Board established Shri Mata Vaishno Devi College of Nursing (SMVDCoN) at Kakryal which started functioning from July 2016. The objective of setting up the College of Nursing is to provide quality nursing education of highest standard to the students so that after passing out from this institution they serve the humanity with utmost commitment and distinction. The establishment of the Nursing College is yet another testimony of the Shrine Board towards its contribution to the society. The College of Nursing is approved by the Indian Nursing Council and J&K Nursing Council and 60 students are admitted to this institution every year. The SMVDCoN is affiliated to Shri Mata Vaishno Devi University. Besides having a highly qualified faculty, the institution is equipped with state-of-the-art infrastructure.

Arrangements are being worked out for providing internship training to the students at the leading health institutions in the



22.4 Shri Mata Vaishno Devi Narayana Superspeciality Hospital

Shri Mata Vaishno Devi Narayana Superspeciality Hospital set up by the Shrine Board at Kakryal near Katra caters to the patients across more than 20 different specialities with focus on cardiac sciences and oncology. This 230-bedded tertiary care hospital, which was inaugurated by the Prime Minister in April 2016, is equipped with state-of-the-art diagnostic and treatment facilities and provides highly specialised and quality medical care at affordable cost.

The hospital, fully equipped with high-end computerised diagnostic and treatment equipments including Linear Accelerator, Brachy Therapy, Gamma Camera, MRI, PET CT, CT Scan, Cath Lab, Endoscopy and Bronchotherapy, most modern Dialysis Unit and other related facilities, has well equipped Critical Care Ambulances and superspecialist doctors

and highly trained nurses, paramedics and other staff. The establishment of this Superspeciality Hospital has completely transformed the medical care scenario in the area with people from within and outside Jammu and Kashmir taking benefit of this facility.

22.5 **Shrine Board's Sports Complex**


The Shrine Board's Sports Complex which was established in 2016 at Katra has become a nerve centre of sports activities and transformed the entire scenario of games and sports in the area. The sports persons trained and groomed at this Sports Complex are winning medals at various national international level competitions. Regular sports events are organised at this Complex as per approved annual calendar of activities, including several major sports events and summer and winter coaching camps, which is contributing significantly towards giving a major boost to the sports culture in the region.
