Engineering Store</u>, <u>Banganga</u>, <u>Katra</u>), payment terms, delivery schedule and other conditions of sale <u>including special discount to SMVDSB</u>.

#### **Terms and Conditions:**

- 1. This is just a RFIQ and not a Purchase Order.
- 2. Rates shall remain valid for a **period of 45 days** from the date of issuance of 1<sup>st</sup> Purchase Order.
- Rate should be NET inclusive of all taxes, having special discount to SMVDSB and the same shall be delivered at Engineering Store, Banganga, Katra within the period mentioned in the subsequent Purchase Order. <u>However, Donations to Shri Mata Vaishno Devi Shrine Board, Katra are exempted from Income Tax under Section 80-G of the Income Tax Act.</u>
- 4. You are requested to send your sealed quotations by or before **03.05.2024 upto 02:00PM**, quotations after due date and time shall not be accepted.
- 5. The material to be supplied should be from the brands / make mentioned in the RFIQ. Any change in the Brand / Make shall be out rightly rejected.
- 6. The quantities mentioned in the format are indicative in nature and can be increased / decreased substantively according to the requirement of SMVDSB.
- 7. The material to be supplied shall be of original make only. Any deviation from the same shall tantamount to rejection of the supplied material and action under rule shall be initiated.
- 8. Shrine Board Reserves the right to split the demand among one or more firms.
- 9. Shrine Board Reserves the right to cancel the RFIQ without any prior notice.
- 10. No Advance payment shall be made. The payment shall be made by Accounts Section after receipt and proper inspection of the consignment received at Engineering Store, Banganga and preparation of GR.

- 11. No extra payment shall be made to the firm on account of the escalation in the material cost, transportation / labour charges during the period of contract.
- 12. The material shall be strictly as per the requirement, specifications as mentioned in the RFIQ.
- 13. The supplier has to mention the price of the material, CGST & SGST separately.
- 14. THE RATES SHOULD STRICTLY BE QUOTED ON THE FORMAT ENCLOSED WITH RFIQ AND AS PER THE SPECIFICATION / UOM / REQUIREMENT. ANY DEVIATION FROM THE SAME SHALL TANTAMOUNT TO REJECTION OF THE OFFER / RATES QUOTED BY YOU. Kindly note that the ISI is not a brand/make of the product.
- 15. The prospective bidder shall have to **submit the authorized dealer / distributor certificate** (if any) along with the sealed quotation.
- 16. The successful firm shall have to provide Warranty on the supplied material as per company's norms. Warranty Certificates of the supplied material shall be enclosed with each supply.
- 17. The material to be supplied shall conform to **relevant BIS/IS certification**. Test Certificates / relevant documents (if any) must be enclosed with each supply.
- 18. On receipt, the material shall be inspected / checked by our Inspection Committee and if found of inferior quality/defective, the same will be rejected and the Board shall be at liberty to have the same procured from open market at the risk & cost of the supplier whereby the original supplier shall be liable to pay the extra cost, if any, involved in the process. The Competent Authority, however, may accept the replaced material within the delivery period if it conforms to the approved specifications.
- 19. In case the material is not delivered within the delivery period, the supplier is liable to penalty for the delay **i.e. i)** upto 07 days @ 0.5% **ii)** from 8<sup>th</sup> day upto 15<sup>th</sup> day @ 1% **iii)** from 16<sup>th</sup> day upto 22<sup>nd</sup> day @ 1.5% and **iv)** from 23<sup>rd</sup> day to 30<sup>th</sup> day @ 2% shall be imposed on each pending item as per the approved rate/quantity mention in the PO of the value of the pending supplies. Further delay shall attract additional penalty @1% every 10<sup>th</sup> day.
- 20. In case of incomplete supply received, an amount equal to 2% of the un delivered material shall be deducted from the due payment of the supplier.
- 21. If the successful bidder / supplier fails to comply with the terms and conditions of the RFIQ as well as the offered rates quoted by the firm after successful culmination of the RFIQ and placing of Purchase order, the same shall be debarred from further dealing with SMVDSB for a continuous period of 03 years.
- 22. The Shrine Board reserves the right to reject, accept or prefer any quotation in part or full without assigning any reason whatsoever at any stage. Shrine Board also reserves the right to re-invite the quotations at its sole discretion.
- 23. The Shrine Board reserves the right to negotiate the quoted rates, terms and conditions with the lowest bidder or any of the other bidder on quality basis to ascertain the suitability of the acceptable offer.
- 24. Conditional, illegible, ambiguous quotation (s) and quotation (s) received after the stipulated date and time shall be out rightly rejected.
