The meeting was attended by all members of SMVDSB – Mahamandleshwar Swami Vishveshvaranand Giriji Maharaj; Baleshwar Rai; Dr Ashok Bhan; Kul Bhushan Ahuja; Dr Neelam Sareen; K K Sharma; Suresh Kumar Sharma (Retd. Judge) and Raghu K. Mehta. Dr Arun Kumar Mehta, Chief Secretary and Sh. Anshul Garg, Chief Executive Officer of the Shrine Board were also present.

He laid the foundation stone of accommodation facilities for Shrine Board's employees at Adhkuwari & Banganga and launched multiple donation facilities for the pilgrims.

Further, the Board discussed, ratified, gave in principle approvals for a total of 46 agenda items. The Board members were also presented with a compliance report on the directions passed for short term and long term measures initiated for yatra regulation and crowd management.

The CEO, SMVDSB apprised the actions initiated on diverse fronts for hassle

The Lt Governor, who is the chairman of Shri Mata Vaishno Devi Shrine Board, launched various initiatives to provide diverse facilities to the pilgrims and devotees.

He also ascertained progress of the work for ease of devotees and laid emphasis on timely completion of all projects. On the occasion, the Lt Governor

verification of RFID cards, effective crowd management, augmentation of holding areas, plans for decongestion of the entire track, separation of entry, exit routes at Bhawan and surveillance through dedicated CCTV network of over 500 cameras.

The Lt Governor directed the CEO to take all necessary measures for the safety and security of the pilgrims. Besides underscored that all aspects should be



taken into account for the construction of Passenger Ropeway between Tarakote Langar and Sanjichhat.

Safety, convenience and ease of the devotees visiting the shrine remains the top priority of the Shrine Board for which emphasis was given on 24x7 monitoring on pilgrimage through RFID and CCTV cameras.

To reform and enhance functions of various departments at the shrine, the Board approved implementation of Enterprises Resource Planning (ERP) software through TCS (Tata Consultancy Services) to provide an integrated digital solution.

The Board approved the establishment of New Registration Counter at Railway Station, Katra to decongest the existing registration counters and provide convenience and comfort to the pilgrims. The Lt Governor also issued directions for building a state-of-the-art Registration centre.

The meeting also decided to invite doctors willing to serve the devotees at the Shrine on volunteer basis through advertisement and wide publicity.

While taking the appraisal of ongoing Projects at Bhawan under Master Plan-Durga Bhawan & Skywalk, the Lt Governor directed to expedite the work.

The Lt Governor emphasized that every effort must be made to complete all the ongoing projects in an expedient manner. The Board impressed for making maximum use of green technologies, rain water harvesting and solar power harnessing.

Discussion was also held on slope stabilization and other upcoming projects including redevelopment of Parvati Bhavan and separate exit track from the Bhawan and remodeling of Manokamna area. The Board also ratified several initiatives for

CEO SMVDSB reviews Master plan projects in Bhawan Area and Underground Cabling Project

Chief Executive Officer, Shri Mata Vaishno Devi Shrine Board on 19th November, 2022 chaired a meeting at Bhawan with the officials of executing agency and concerned engineers to review the pace of ongoing mega projects at Bhawan which include Durga Bhawan and Sky-Walk. The review meeting was held immediately after the visit of Chairman, SMVDSB (Hon'ble Lt. Governor, JK-UT) who visited Holy Shrine and conducted inspection of ongoing projects.



Reviews of Master Plan projects in Bhawan area by CEO

Durga Bhawan, which is likely to be commissioned shortly, has provisions to accommodate 2500 pilgrims on a daily basis, bound to give a new shape and structure to the comforts and convenience of the pilgrims visiting the Holy Shrine. The building once completed shall have provisions for providing locker facilities to keep valuables by the staying pilgrims coupled with bathing ghats, aimed at making the stay quite pleasant and congenial, besides, providing hygienic and wholesome food at nominal rates.

Construction of Durga Bhawan is part of the approved Master Plan of Bhawan area, prepared by the School of Planning and Architecture, New Delhi. The Master Plan seeks to achieve the target of ensuring maximum accommodation for pilgrims by 2031.



The CEO also reviewed the status of Sky-Walk, conceptualized by the Shrine Board to overcome the problem of multidirectional flow of yatra and a chaotic condition at Bhawan. It has been designed by the School of Planning and Architecture, New Delhi and is being executed by Central Public Works Department (CPWD) with technical vetting by Indian Institute of Technology (IIT) Roorkee.

While reviewing the progress, the CEO stressed upon the executing agency and concerned engineers to work with an added dedication and ensure completion of ongoing mega projects within the stipulated time frame. He asked the executing agency to redouble their efforts in mobilizing men and machinery for completing the projects in stipulated time frame.

Chief Executive Officer also took a comprehensive review of the present status of the implementation of Underground Cabling Project enroute the Holy shrine at a meeting held at Kalika Dham, Jammu on 23rd November.



Reviews of progress on Underground Cabling Project

The underground cabling work from Katra to Bhawan and in the surrounding areas has been allotted to the M/s JSP Projects P. Ltd. by JPDCL (Project Wing) on the basis of tendering process, partially funded under the PMDP and by the Shrine Board at an estimated cost of 85.99 cr. This high utility project will have a SCADA compliance based monitoring system of the electric network.

Taking an extensive review and cognizance of inordinate delays completion of project, the Chief Executive Officer stressed for expeditious completion of the pending foundations inter-alia of Package Sub-Station (PSS), Ring Main Units (RMUs), Feeder Pillars, Chemical Street Poles vis-a-vis earthing. synchronization of SCADA station on complete track, besides, ensuring all the remaining supplies. The Chief Engineer (Project Wing), JPDCL and Coordinator. RECPDCL were asked for close monitoring of works on daily basis, while ensuring adequacy of manpower, machinery, material and all other wherewithal for completion of the entire work before ending of December.

Chief Executive Officer, SMVDSB asked the Project Director, executing agency to achieve results on the ground and ensure its entire completion expeditiously and strictly as per the revised timelines. Besides, directed the officials to work in close synergy to remove any bottlenecks coming in the way of progress of works.

CEO underscored that with the determined efforts of the Shrine Board and blessings of the Divine, yatra to the holy shrine has tremendously increased as compared to the previous two years which has been possible due to the all round efforts of all the stakeholders. Reviews meeting for security and operational preparedness ahead of New-year

CEO urged for simulating exercises jointly to deal with crowd management well for effective Yatra management on ground on the eve of New Year. To review each and every security aspect of the Shrine area enroute besides, safety and security of pilgrims expected to visit in huge volume on New Year, he emphasized to conduct joint drills well in advance and plug any gaps. A slew of directives were issued to the Sub-Divisional Magistrate, Bhawan for physical and systematic improvements wherever required at Bhawan and allied areas after critical examination.

CEO also deliberated on various measures in place and proactive steps taken for smooth regulation of expected influx of pilgrims likely to visit in large number from various parts of the country and abroad to abode of Shri Mata Vaishno

Devi ji on the onset of New Year which includes issuance of RFID cards, effective crowd management, working out plans for decongestion of the entire track, particularly the Bhawan area, separation of entry, exit routes at Bhawan and all time surveillance through dedicated CCTV dedicated network of over 500 cameras.

CEO said that yatris are being regularly informed through announcement to register under RFID based Registration Card through Shrine Board Registration Counters only before start of their pilgrimage and if any pilgrim found without RFID cards, he will not be allowed for the pilgrimage. He also underscored that those pilgrims registered under RFID not returning their card after completion of Yatra shall be charged a fine of Rs 100/- as deterrence.



SMVDSB held 2nd review of Yatra preparedness ahead of New-year

CEO, SMVDSB also discussed the concern about surge in COVID cases and informed that all the stakeholders have been advised to wear masks while dealing with the yatris. He also informed that the Shrine Board has made wearing of face masks mandatory for every pilgrim attending the Atka Arti and in the darshan queue.

Suresh Kumar Sharma, Member, Shrine Board while reviewing the various mitigation measures in place emphasized coordinated efforts amongst all stakeholders for working on strategies for



risk aversion and identifies the congestion and crowd holding spots for better crowd management before the onset of New Year.

P. S. Ranpise, IG, CRPF highlighted major challenges for the deployed security forces in coming days for managing the expected influx of pilgrims on New Year. Besides, DIG, J&K Police informed that additional forces as per request shall be deployed in and around Katra and on the track enroute Bhawan in coordination with other security agencies to ensure fool-proof security and effective Yatra management.

SSP Reasi presented a detailed security grid in place and discussed various security measures going to be placed on the eve of New Year.
