The following changes / modifications / additions are hereby notified in the tender document:

1	Clause No. 9 DELIVERY PERIOD : The successful bidder(s) shall have to deliver the material within 15 days time period from the date of issuance of purchase order(s) to be issued during the validity of rate approval order. The material shall be supplied immediately from ready stock from the date of placement of purchase order. Before participating, the competing firm must ensure that it has the capacity to meet the delivery period criteria. The Shrine Board may or may not extend the delivery period.	The successful bidder(s) shall have to deliver the material within following timeline from the date of issuance of purchase order(s) to be issued during the validity of rate approval order: ➤ For commercial lighting : 60 days ➤ For non-commercial lighting: 15 days. The material shall be supplied immediately from ready stock from the date of placement of purchase order. Before participating, the competing firm must ensure that it has the capacity to meet the delivery period criteria. The Shrine Board may or may not extend the delivery period.
2	Clause No. 15, Warranty : The bidders shall be fully responsible for the manufacturer's warranty for a period of 02 years from the date of receipt of item(s) at Engineering Store, SMVDSB, Katra. The successful bidder shall have to provide free replacement of defecting items during the period of warranty of 02 years.	The bidders shall be fully responsible for the manufacturer's warranty from the date of receipt of item(s) at Engineering Store, SMVDSB, Katra as per detail: ➤ 2 years in case of item No. item No. 10, 11 & 12 of Annexure "F" of e-NIT ➤ 3 years in case of battens (Item No. 1 & 2) ➤ 5 years for rest of items of Annexure "F" of e-NIT The successful bidder shall have to provide free replacement of defecting items during the period of warranty.
3	Item No. 1 & 2 of Annexure "F" of e-NIT	Batten surge should be 2.5 KV to 3KV and IP40
4	Item No. 3 of Annexure "F" of e-NIT	Surge should be 3KV - 4KV
5	Item No. 5 & 6 of Annexure "F" of e-NIT	Surge should be 2.5KV to 3KV
6	Item No. 7 of Annexure "F" of e-NIT	➤ 30-36 W LED 2 Feet X 2 Feet Recessed Mounted, and ➤ System efficacy of 115-120 lm/w
7	Item No. 8 of Annexure "F" of e-NIT	➤ 30-36 W LED 2 Feet X 2 Feet Recessed Mounted ➤ THD≤10%, ➤ Surge 2.5KV to 3KV
8	Item No. 9 of Annexure "F" of e-NIT	➤ 30- 36 W LED 2 Feet X 2 Feet Surface Mounted, ➤ System efficacy of 115-140 lm/w

In addition, following Clause shall deem to be incorporated in the ibid e-NIT which shall read as under:

“SMVDSB shall reserve the right to get the sample testing / inspection, after receipt of material, through Govt. approved NABL Lab. The cost shall be borne by the manufacturer / supplier”

- All other terms and conditions of the original e-NIT shall remain unchanged.
- This Corrigendum/ Addendum shall be treated as an integral part of the original tender document.
- Bidders are advised to take note of the above changes before submitting their bids.
