Request for Inviting Quotations (RFIQ)

For and on behalf of Shri Mata Vaishno Devi Shrine Board; through Chief Executive Officer (herein after referred as SMVDSB), offers are hereby invited from reputed manufacturers / distributors / dealers / suppliers only for furnishing the rates for SITC of CCTVs and allied accessories as per specifications, Brand and Make mentioned in **Annexure-“A”**:

Terms and conditions:

1. **Document to be submitted:**

- i) GST Certificate.
- ii) Data Sheets in respect of Camera, NVR and Switch are required to be enclosed.
- iii) Copy of the RFIQ document, duly signed and stamped on each page by the participating bidder, confirming acceptance of all the contents, terms and conditions contained therein.
- iv) Certification w.r.t. authorized manufacturer / distributor / dealer, (if any).

2. **Last date for submission of sealed quotation:**

By or before **13.06.2026 upto 02:00PM** at Central Office, Katra through Speed Post / Registered Post / reputed courier / by hand.

3. **Validity:** The validity of quotation should be 20 days from the last date prescribed for submission.

4. It shall be noted that the live feed from the CCTV cameras to be installed at each site the locations should be made accessible at the Integrated Control Command Centre (ICCC) located at SGC.

5. Quantity mentioned in RFIQ is indicative and can be increased or decreased as per requirement.

6. **Rate**

- i) The rates should be NET inclusive of GST, loading, unloading, labour charges, toll tax, freight and other taxes / charges / F.O.R. Engineering Store, Banganga.
- ii) The CCTVs and allied accessories shall be installed at the locations mentioned in Annexure – A.
- iii) The successful firm shall supply / deposit the material at Engineering Store for inspection. Thereafter the CCTVs and allied accessories shall be installed at the locations mentioned in Annexure – A.
- iv) The participating firms are advised to quote rate for each site separately (inclusive of all) (Rates excluding GST and Ex-Shop shall not be considered even after opening of the quotation).

➤ Any unused material/equipment, as detailed in Annexure–A, shall be handed over to the concerned unit for further utilization under proper challan, with due intimation to the IT Section.

7. **Delivery:** The SITC shall be completed within a period of **20** days from the date of issuance of respective Order. Before participating, the competing firm must ensure that it has the capacity to meet the delivery period criteria. The Shrine Board may or may not extend the delivery period.

8. **Earnest Money Deposit:**

- i. Earnest Money Deposit in the shape of **CDR / FDR / TDR** amounting to Rs. **18,000/- (Rupees Eighteen Thousand only)** of any Nationalized / Scheduled Bank duly pledged to the FA & CAO, SMVDSB must be enclosed with the quotation.
- ii. Alternatively, the bidders may also transfer the required amount on account of EMD in online mode (**IMPS / NEFT / RTGS**) in the following account of the Shrine Board:

- iii. In case of online transfer, the print-copies of screenshots of transaction must be enclosed with the quotation. In addition, the full details of the Bank Account from which the transaction has been made shall have to be written on the body of the Transaction Screenshot. The transaction to the account specified above shall only be accepted. **The transaction made to any other account of Shrine Board shall be treated as failure to deposit the prescribed EMD.**
 - iv. Furnishing of EMD for an amount less than the stipulated amount mentioned in the RFIQ quoting the exemption as Small Scale Industries or any other reason shall not be entertained and the quotation / offer submitted by the firm shall be rejected outrightly. The quotation will be considered only for those firms who had submitted requisite EMD.
 - v. The EMDs of all unsuccessful bidders shall be returned after the issuance of Purchase Order(s).
 - vi. The EMD of the successful bidder shall be released only after the successful SITC of complete material as per terms & conditions of the PO.
9. The conditional, illegible, ambiguous quotation (s) and quotation (s) received after the stipulated date and time shall be outrightly rejected.
10. The material to be supplied strictly should be from the brands / makes / specifications mentioned in the RFIQ. No change in the Brand / Make shall be accepted. Any change in the Brand / Make shall outrightly be rejected. Kindly note that the ISI is not a brand / make of the product.
11. The rate of the successful firm(s) shall be considered on an L-1 basis separately for each site(s).
12. **INSPECTION / LIFTING BACK OF REJECTED SUPPLIES:**
- a. On receipt, the material shall be inspected / checked by our Inspection Committee and if found of inferior quality/defective, the same will be rejected and the Board shall be at liberty to have the same procured from open market at the risk & cost of the supplier whereby the original supplier shall be liable to pay the extra cost, if any, involved in the process. The Competent Authority, however, may accept the replaced material within the delivery period if it conforms to the approved specifications.
 - b. The rejected material shall have to be lifted by the supplier at his own risk and cost within a week's time, failing which storage charges @ 2% per day shall be imposed against the supplier for a period of one week. The penalty amount shall get doubled for each subsequent week and the rejected material in the stores shall be at the risk of the firm. Beyond one month the material shall be auctioned and storage charges shall be recovered from the supplier @2% per day. The amount acquired on account of auctioning shall be deposited to SMVDSB Account.
13. **Penalty:** Following penalties (calculated on the value of unsupplied material) shall be imposed for delay beyond the prescribed delivery/installation period, unless exempted by the competent authority for valid reasons to be brought on record.
- a) upto 4 days @ 0.5%
 - b) From 5th day to 6th day @ 1%
 - c) From 7th day to 8th day @ 1.5% and
 - d) From 9th day to 10th day @ 2% shall be imposed on each pending item as per the approved rate/quantity mentioned in the purchase order of the value of the pending supplies.
 - e) After 10 days of delay, the rate approval order / purchase order shall be deemed to have been cancelled to the extent of unsupplied material and the material shall be procured from alternative sources at risk and cost of vendor.

Note: Despite cancellation of Purchase Order as stated above; for any valid reason to be brought on record, the Competent Authority may grant extension in the stipulated delivery period; with or without penalty. (Amount to be decided by the Competent Authority).

14. **Force Majeure:**

Any failure or omission to carry out the provisions of the order shall not give rise to any claim by one party against the other, if such failure or omission arises from an "Act of God" which shall include all acts of Natural Calamities such as fire, flood, earthquakes, hurricanes, pandemics or any pestilences or from civil strikes, compliances with any statute or regulations of the Government lock outs and strikes, riots, embargoes or from any other reasons beyond the control of the parties.

15. All disputes arising hereto are subject to Jurisdiction of the Courts of Law at Katra / Reasi.

16. **Payment:**

- a) No Advance payment shall be made.
- b) 90% payment shall be released after the successful installation and commissioning of work i.e. supply/installation/testing/commissioning (SITC) of CCTV Cameras and its allied accessories, subject to satisfactory report received from I/c IT Wing, SMVDSB.
- c) Balance 10% payment shall be released after expiry of Warranty period of 01 year subject to satisfactory report received from I/c IT Wing.

17. **Warranty (if any):**

- a) The successful firm shall provide onsite warranty of atleast 1 year on the applicable items.
- b) The warranty shall start from the date of commissioning of CCTVs at Site(s).
- c) The successful firm shall be responsible for providing Guarantee / Warranty to SMVDSB on the supplied material. Warranty / Guarantee Certificate shall be furnished at the time of supply of material. The supplier shall be fully responsible for any manufacturing defects and shall provide onsite warranty / guarantee service after sales.

18. **Rights reserved by SMVDSB:** The Competent authority of SMVDB reserves the right:

- a) To cancel/ terminate the RFIQ / Purchase Order during the period of its validity without assigning any reason thereof.
- b) To forfeit the CDR/FDR of defaulter supplier.
- c) Debarring any defaulter firm from any further dealing with Shrine Board for a period of three years.
- d) Grant of extension with or without imposing penalty, as deemed fit.
- e) To visit the premises of the bidder to verify the production capacity of the bidder / quality of products.
- f) The Board reserves the right to establish reasonability of rates, to negotiate with the L-1 bidder for each item or to bifurcate the Rate Approval / Purchase Order amongst more than one bidder (on L-1/negotiated rates).

19. This is just a RFIQ and not a Purchase Order.

20. The broad terms and conditions have been included. However, other standard terms and conditions of supply may be incorporated in the Rate Approval Order / Purchase Order to be issued in due course.

21. **PROCEDURE FOR SUBMISSION OF BID:**

The firm shall submit the **Price Bid** on their letter head as per **Annexure "III"**, in a sealed envelope super-scribed "**QUOTATION FOR SITC of CCTVs and allied accessories**" against **RFIQ No. CO/Pur/Electronics/26/521/766** dated: **06.06.2026** which shall contain all relevant details along with requisite Earnest Money Deposit, if any.

22. All such offers, along with the terms and conditions duly signed, and enveloped as described above, must be submitted in person in the office of the SMVDSB, Katra by 02:00 PM (1400 hrs) on **13.06.2026**. Alternatively the sealed offer may be sent by Registered Post /Speed Post/ Courier addressed to the office of the Chief Executive Officer, Central Office, Jammu Road, Katra (J&K) - 182301 so as to reach by 02:00 PM (1400 hrs) on **13.06.2026**. The offer(s) received after the due date and time shall not be considered under any circumstance.

23. The quotations shall be opened by the Committee, at the Office of Chief Executive Officer, SMVDSB, Katra in the presence of the bidders who may choose to be present.

24. The Shrine Board shall not be responsible for any delay in submission of quotation whatsoever. Any conditional offer or offers which are not appropriately sealed as per the format, as explained above, or offers received after the stipulated date and time, shall not be entertained. Any cutting or overwriting in the Documents will also make the bid liable for rejection.
